## SECTION 4: FIRST AID MEASURES

### 4.1 Description of first aid measures:

Request medical assistance immediately, showing the MSDS of this product.

#### By inhalation:

This product does not contain substances classified as dangerous for inhalation, however, in case of symptoms of intoxication remove the person affected from the exposure area and provide with fresh air. Seek medical attention if the symptoms get worse or persist.

#### By skin contact:

Remove contaminated clothing and footwear, rinse skin or shower the person affected if appropriate with plenty of cold water and neutral soap. In serious cases see a doctor. **By consumption:**

**5.1 Extinguishing media:**

Product is non-flammable under normal conditions of storage, manipulation and use.
